# Working in Japan Following High School Graduation

The Immigration Service Agency of Japan permits foreign residents with Dependent residency status accompanying their parents who find work in Japan after high school graduation to change their visa status to Long-Term Resident or Designated Activities status.

#### **Main Requirements**

Long-Term Resident	Designated Activities
Graduating from Japanese elementary and junior high school.	—
Graduating or expected to graduate from Japanese high school.	Graduating or expected to graduate from Japanese high school. If transferred, having Japanese language proficiency equal to N2.
—	Having your supporter (father, mother, etc.) in Japan.
Having been residing in Japan with Dependent residence status since entering Japan.	
Under 18 years old when entering Japan.	
Having found (including receiving an informal offer from) a place of employment. Working hours must exceed 28 hours per week.
